## Passenger No. 1:Emmaline Wolfgram; female; 80; of Niagra, ND; uninjuredRestraints:Seat belt in use, no air bag deployed

**NARRATIVE:** Visocsky, Longtine, and Wolfgram were driving their respective vehicles east on US Highway 2. Wolfgram and Longtine were slowing for slowed or stopped traffic ahead as they approached the intersection with Airport Road. Visocsky was unable to adequately slow the GMC in time to avoid a collision. The front of his GMC struck the rear of the Chevrolet, and the front of the Chevrolet was pushed into the rear of the Subaru. No occupants were injured.

The vehicles were moved to the shoulder after the collision, and traffic was not obstructed as a result of this crash.
