## Fatality Crash - Grand Forks County, North Dakota UPDATED

What: Fatality Crash

Where: US Highway 2 & Airport Road ~ 3 ½ Miles West of Grand Forks, North Dakota

When: July 2, 2021 @ 7:36 A.M.

**Road Conditions:** Good, active construction work zone where both eastbound and westbound motor vehicle traffic are head-to-head occupying the normal eastbound lanes of US Highway 2. The westbound lanes of US Highway 2 are closed and currently under construction.

Weather Conditions: Clear, Sunny

**Crash Involvement:** 8 Vehicle

Type of Crash: Rear-end

**Agencies Involved:** North Dakota Highway Patrol, University of North Dakota Police Department, Grand Forks County Sheriff Department, Grand Forks Police Department, Altru Ambulance Service, Interstate Towing & Recovery

Charges: Crash is under investigation and no charges have yet been determined.

**NARRATIVE:** On July 2, 2021, at approximately 7:28 A.M. an eastbound semi-tractor towing a bottom dump trailer was reported as swerving and traveling on the rumble strips, or edge line of the eastbound lane of US Highway 2 at mile marker 349.00. Approximately eight minutes after receiving the initial call for service, several emergency calls were received of a crash involving multiple motor vehicles located at the intersection of US Highway 2 and Airport Road west of Grand Forks.

Vehicles 2, 3, 4, 5, 6, 7, and 8 were stopped or slowed on the west side of the intersection of US Highway 2 and Airport Road, waiting to travel east. Vehicle 1, a Volvo truck tractor with belly dump trailer driven by Piechowski, was traveling east approaching the intersection. Piechowski failed to stop his vehicle, and the front of the Volvo struck the rear of Vehicle 2 and traveled into the group of stopped vehicles. The Volvo eventually ran off the road into the south ditch.

Jayne died as a result of injuries sustained in the crash. Several other drivers and motor vehicle occupants were injured and were transported by ambulance to Altru Hospital in Grand Forks for non-life-threatening injuries of varying degree sustained in the crash.

US Highway 2 in the area of the crash was closed to all motor vehicle traffic for approximately 6 hours for crash scene investigation and crash scene clean-up. All motor vehicles involved sustained disabling damage and were towed from the crash scene.

The crash remains under investigation by the North Dakota Highway Patrol.
