NARRATIVE: The Jeep Grand Cherokee, driven by Cruz, was south bound on ND Highway 18 at mile marker 64. The Dodge Caravan driven by Parras was northbound at the same location. This location was marked no passing and on a curve.

A southbound motorist had stopped at and was waiting to turn left onto a gravel road. Cruz was distracted by his GPS and did not realize traffic had stopped in front of him. Cruz drove into the NB lane to avoid a rear end crash. The Dodge Caravan was north bound and the front passenger side bumper struck the Caravan's front bumper.

The Jeep entered the east ditch of Highway 18 and rolled, coming to rest on its passenger side. The Dodge came to rest in the middle of the roadway. Both vehicles suffered heavy damage and were totaled in the collision. The juvenile passenger from the Caravan was extricated by Fire and Rescue and then flown by Sanford AirMed to Sanford Hospital in Fargo. Parras and all occupants of the Jeep were taken by ambulance to Sanford Hospital in Fargo. None of the injuries appear life threatening.

The juvenile will not be identified by the NDHP. Cruz was cited for Overtaking Where Prohibited and Failure to Maintain Control - Distracted Driving. The crash remains under investigation by the NDHP.
