NARRATIVE: Driver 1 was traveling eastbound on US Highway 281 while Driver 2 was traveling westbound on US Highway 281. An eastbound noncontact motor vehicle was stopped in traffic on US

Highway 281 yielding to Vehicle 2 and was waiting to negotiate a left turn to travel north on 52nd Avenue NE. Driver 1 attempted to overtake the noncontact motor vehicle just west of the intersection of US Highway 281 and 52nd Avenue NE. Driver 1 struck Driver 2 head-on and both motor vehicles entered the north ditch after the collision occurred. Vehicle 1 after impact came to final rest facing mostly west on its wheels while Vehicle 2 came to final rest facing mostly south on its wheels. All occupants needed to be extricated due to the severe damaged sustained to their respective motor vehicles.

The name of the deceased will be released on Tuesday, September 14, 2021, to allow notification of next-of-kin. The crash remains under investigation by the North Dakota Highway Patrol.
