NARRATIVE: North Dakota Highway Patrol troopers were conducting a traffic stop on the shoulder of the westbound lane of I-94, just east of the Grant Marsh Bridge in Bismarck at 4:23 p.m. CT, September 20, 2021. Trooper squad vehicles had the emergency lights activated which required motorists to move over or slow down prior to passing the stopped emergency vehicles. Willard Desjarlais, driving a blue Hyundai Elantra, was traveling west, and slowed to pass the stopped emergency vehicles. The Elantra was struck in the rear by a Chevrolet Traverse, operated by Dennis Doll. Doll's Traverse was then struck in the rear by a Toyota Highlander, driven by June Schettler. The Traverse came to rest in the middle of both lanes, straddling the centerline and blocking both westbound lanes. Schettler's Highlander came to rest facing south, blocking the shoulder and part of the right lane. Desjarlais was able to move his Elantra out of the roadway and park on the shoulder.

Bertha Appert, driving a Chevrolet Equinox, stopped behind the initial crash. A Dodge Durango, operated by Janine Wetzel, stopped behind Appert's vehicle. Mickey Frost, operating a Mitsubishi Galant, failed to stop, and struck the rear of Wetzel's Durango, pushing it into Appert's Equinox. The three vehicles: Equinox, Durango, and Galant; all came to rest in the left lane facing east.
