NARRATIVE: Schmidt was eastbound on $5^{\text {th }}$ Street $S$ crossing University Drive in Fargo when he was struck by the Jeep Grand Cherokee. The Jeep was traveling at a high rate of speed after fleeing a traffic stop by Fargo, PD. The front of Jeep stuck the driver side door of the Mazda 6. After crashing the vehicles struck nearby trees and a power line. The Mazda came to rest in the middle of University Drive and the Jeep came to rest in a residential yard on the east side of University Drive. Both vehicles suffered heavy damage in the crash. Schmidt was transported by FM Ambulance to Fargo Sanford for treatment of serious injuries. Alau and Northern were transported by FM Ambulance to Essentia Health for treatment of serious injuries. The driver of the Jeep fled from the scene before Law Enforcement arrived. The crash remains under investigation by the NDHP. Xcel Energy was called to the scene and stabilized the damage done to a utility pole. The intersection was closed for several hours while the crash was investigated.
