### **Three Vehicle Injury Crash**

**NARRATIVE:** A 2015 Chevrolet Cruze was north on 25<sup>th</sup> St. S. and was making a left turn onto 17<sup>th</sup> Ave. S when it was struck by the 2012 Hyundai Sonata. The Hyundai Sonata was south on 25<sup>th</sup> St. S. prior to striking the Chevrolet Cruze. A 2019 Jeep Cherokee was east on 17<sup>th</sup> Ave S. and was stopped at the intersection of 25<sup>th</sup> St. south due to having a red light. The Hyundai Sonata broke impact with the Chevrolet Cruze and struck the Jeep, which was stopped in the right turn lane, causing the Jeep to rollover onto its side. The occupants of the Jeep had to be extricated by Fargo Fire. The injured parties were transported to local hospitals for treatment of their injuries by Sanford Ambulance. This crash remains under investigation by the North Dakota Highway Patrol
